Prayer : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the 2nd respondent to consider and dispose the petitioner's representation dated 04.09.2025 in accordance with law and thereby direct him to cancel the sub-division made in Survey No.24/2B into Survey No.24/2B1 and Survey No.24/2B2, in respect of the property situated at Somangalam Village,

Kundrathur Taluk, Kancheepuram District and also to Cancel the Patta No.7807 which was issued in the name of the 4th respondent's father i.e. Kannan and consequently direct him to issue the Patta No.701, to an extent of 17 cents of land in the petitioner's daughters' name i.e 1)Yasodha, 2) Neela, 3) Aandal, 4) Suguna and 5) Vachala in respect of the said property, within a time limit to be stipulated by this Court.

ORDER

This Writ Petition has been filed to direct the 2nd respondent to cancel the patta bearing No.7807 standing in the name of the 4th respondent for the property morefully disclosed in the prayer to this writ petition, based on the petitioner's representation, dated 04.09.2025, within a time frame to be fixed by this Court.

2. The petitioner claims that illegally, the 4th respondent had obtained patta No.7807 in his name for the property morefully disclosed in the prayer to this writ petition. She seeks for cancellation of the same and had given a representation, dated 04.09.2025 for the said purpose.

Since the same was not considered, the petitioner has filed this writ petition.

4. No prejudice would be caused to any of the respondents, if the petitioner's representation as stated supra is considered on merits and in accordance with, after hearing the objections of the 4th respondent or any other third party, whom the 2nd respondent deems it fit to enquire, within a time frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioner's representation.

5. For the foregoing reasons, this Court directs the 2nd respondent to pass final orders, on merits and in accordance with law, on the petitioner's representation, dated 04.09.2025 seeking for cancellation of patta No.7807 standing in the name of the 4th respondent for the property
