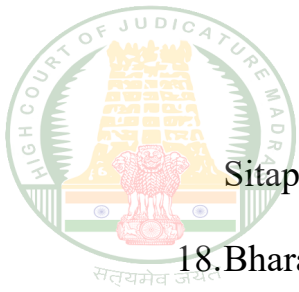

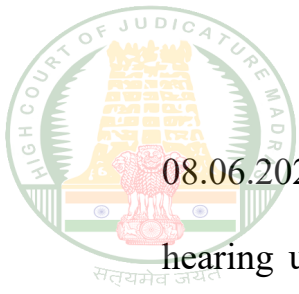
Writ Petition is filed under Article 226 of Constitution of India, seeking to issue a Writ of Certiorari Mandamus, Calling for the records of the impugned order of the third respondent vide IRDA/NL/ NTFN/MOTP/ 053/03/2018 dated 28.03.2018, and to quash that portion of the impugned order in increasing the third party premium for insurance of public carrier goods carrying vehicles (1)exceeding 7500kgs. but not exceeding 12000kgs (2)exceeding 12000kgs but not exceeding 20000 kgs and (3)exceeding 20000kgs but not exceeding 40000 kgs and exceeding 40000kgs under category A1 and further to direct the third respondent to reconsider the premium rates for the financial year 2018-2019 for goods carrying public carriers
