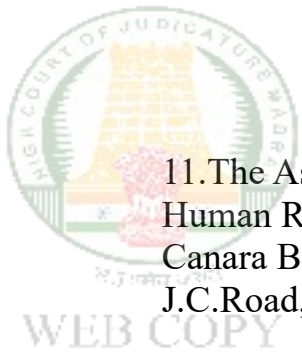

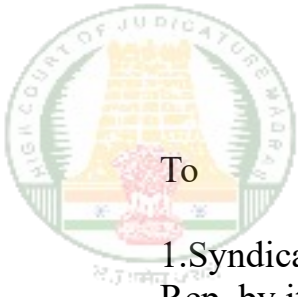
Heard the learned counsel for the petitioners and the learned Standing Counsel appearing on behalf of the respondents.

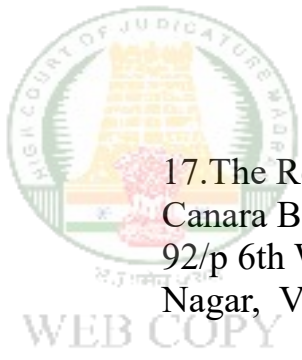
