ORDER

WEB COPY

This criminal original petition has been filed seeking to quash the proceedings in S.T.C.No.1848 of 2025 on the file of the Judicial Magistrate Court No.I, Ramanathapuram, pending against the petitioner.

2. The case of the prosecution is that on 03.04.2024, the petitioner, who contested as a candidate in the Parliamentary Constituency election at Ramanathapuram, along with his party members, acted in violation of the election rules, by coming in more than three cars and conducting an election campaign, thereby, causing obstruction to the free flow of traffic and inconvenience to the general public. Consequently, a case in Crime No.67 of 2024 was registered by the 1st respondent police for the offences under Sections 143 & 283 IPC. After completion of investigation, the final report was filed before the learned Judicial Magistrate No.I, Ramanathapuram for the abovesaid offences and the learned Magistrate took cognizance of the same and numbered it as S.T.C.No.1848 of 2025, which is now sought to be quashed.

3. Learned counsel appearing for the petitioner submitted that the facts of the instant case are similar to the facts of the cases in

Jeevanandham and others vs. The Inspector of Police,

Velayuthampalayam Police Station, Karur District reported in (2018 2 LW (Crl) 606) and Sri Raja vs Inspector of Police, Sivakasi Town Police Station Virudhunagar District and others (Crl.O.P(MD) No.7922 of 2019, decided on 30.08.2019), in which the proceedings were quashed. Hence, he prayed to quash the proceedings pending against the petitioner.

4. Learned Additional Public Prosecutor appearing for the 1st respondent police, on instructions from Mr.L.Veera Ganesan, Sub-Inspector of Police, Thiruvadanai Police Station, Ramanathapuram District, submitted that based on the complaint given by the 2nd respondent, Executive Magistrate, Flying Squad, 210, Thiruvadanai Assembly Constituency, the aforesaid case came to be registered on 03.04.2024. He further endorsed the aforesaid submission of the learned counsel for the petitioner that the facts of the instant case are akin to the facts in the aforesaid two cases.

5. Heard the learned counsel appearing on either side and perused the materials available on record.

6. In view of the above, this Court is of the opinion that the abovesaid two decisions would apply on all fours to the present case and that no useful purpose will be served by keeping the impugned proceedings pending and the same is liable to be quashed.

7. Accordingly, this criminal original petition stands allowed and the impugned proceedings pending against the petitioner in S.T.C.No.1848 of 2025, on the file of the Judicial Magistrate Court No.I, Ramanathapuram, is hereby quashed. Consequently, the connected miscellaneous petitions are closed.
