For the foregoing reasons, this writ petition is disposed of by directing the 3rd respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 18.11.2022 seeking for correction of the alleged computer entry in the Patta standing in the name of the petitioner for the property, morefully described in the prayer to this writ petition, after giving due consideration to the supporting documents produced by the petitioner, within a period of twelve (12) weeks from the date of receipt of a copy of this order.
