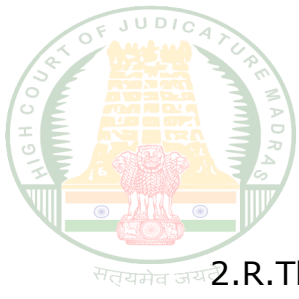

2. This writ appeal filed under Clause 15 of the Letters Patent assails the order dated 10.2.2026 passed in W.P.No.3000 of 2026 whereby certain directions were issued by the learned Single Judge while disposing of the writ petition.

During the course of hearing, by producing proceedings of the 5th respondent dated 16.4.2026, learned State counsel submitted that the directions contained in the order passed by the learned Single Judge have been complied with. this writ appeal is rendered infructuous.

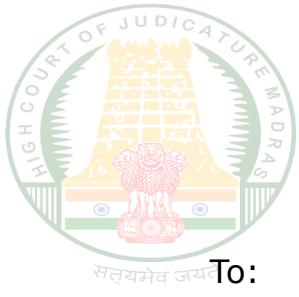
