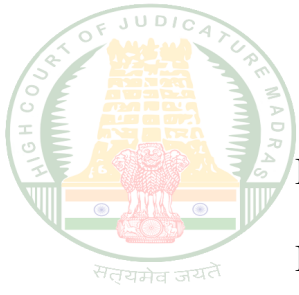

2. Recording the submissions made by the learned counsel for the petitioner, this Contempt Petition is closed.

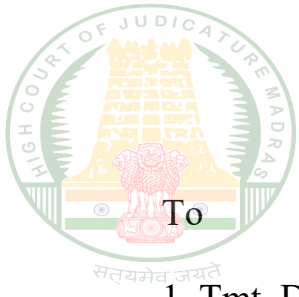
