ORDER

Since this Court expressed its view that there is no infirmity in the impugned refusal check slip dated 30.01.2026 issued by the 3rd respondent, refusing to register the sale deed presented by the petitioner for registration on the ground that there is an injunction decree passed in favour of the third party pertaining to the very same property restraining the petitioner's husband from alienating/encumbering the property, the learned counsel for the petitioner has now made an endorsement in the Court bundle, seeking permission of this Court to withdraw this Writ Petition, but however, seeks liberty for the petitioner to approach the said Civil Court or to approach any other higher Court to vacate the interim injunction.

2. Accordingly, this Writ Petition is disposed of by granting liberty to the petitioner as prayed for. However, there shall be no order as to costs.
