5. To await report from the mediator, list under the same caption 'to report progress in mediation' on 01.04.2026.

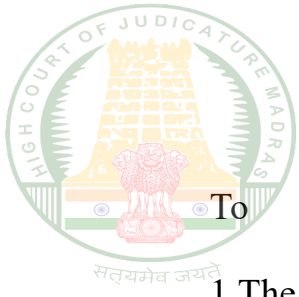
