ORDER

This writ petition has been filed to direct the respondents to rectify the mistake in the FMB Sketch and "A" Register for the property morefully described in the prayer to this writ petition based on the petitioner's representation dated 20.01.2026 within a time frame to be fixed by this Court.

2. According to the petitioner, the present FMB Sketch and "A" Register for the property is not in accordance with the sale deed standing in the name of the petitioner. In such circumstances, the petitioner seeks for rectification of the FMB Sketch and "A" Register. The petitioner had given a representation on 20.01.2026 to the respondents for rectification of the FMB Sketch and "A" Register. Since the said representation has not been considered till date, this writ petition has been filed.

3. Mr. S.Arumugam, learned Government Advocate accepts notice on behalf of the respondents.

4. No prejudice would be caused to the respondents if the petitioner's representation as stated supra is considered on merits and in accordance with law after giving due consideration to the supporting documents filed by the petitioner within a time frame to be fixed by this Court.



5. This Court is not expressing any opinion on the merits of the petitioner's representation.
