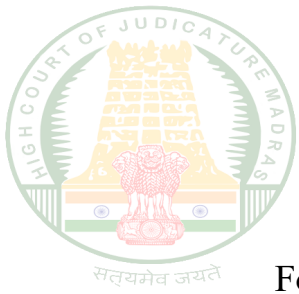

JUDGMENT

2. It is seen from the records that earlier, this Court, on 20.04.2026 had referred the matter to the Mediation and Conciliation Centre, High Court, Madras. Accordingly, the parties have appeared before the Mediation and Conciliation Centre, High Court of Madras and arrived at a compromise and entered into a Joint memo of compromise and the mediation centre has sent a report dated 28.04.2026 to this Court. The 1st defendant appeared in person before the court and the
