2.The learned counsel appearing for the petitioner submitted that the petitioner made representation dated 25.07.2023 to the respondents 1 and 2 seeking medical reimbursement and vide communication dated 26.05.2025, the same was forwarded by the second respondent to the third respondent, however, there is no response.
