5. Considering the limited nature of the prayer sought for and without expressing any opinion on the merits of the case, the writ petition is disposed of with a direction to the petitioner to approach the second respondent with a copy of the said representation dated 02.4.2025 within two weeks from the date of receipt of a copy of this order. On receipt of such representation, the second respondent shall consider the same on merits and pass appropriate orders thereon in accordance with law within a period of four weeks therefrom.
