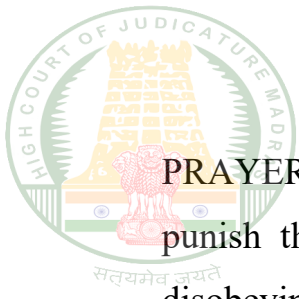

This Contempt Petition has been filed to punish the respondents for not complying with the order of this Court made in W.P.No.36193 of 2024 dated 28.11.2024.

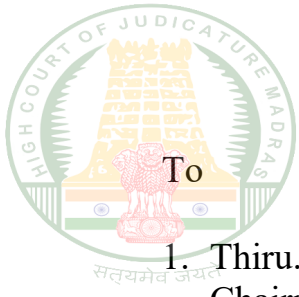
