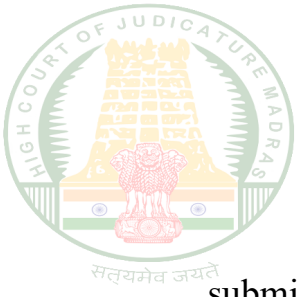

Vellore, in the presence of the Ist Additional District and Sessions Judge,

Mr. S.Nagarajan, on 07.07.2026.

6.The Registry is directed to send a copy of this order to the Family

Court, Vellore, the Family Court, Salem and Ist Additional District and

Sessions Judge.
