This petition has been filed under Article 226 of the Constitution of India seeking a direction to respondents to immediately restrict the opening of the TASMAL Retail Liquor Shop No.202 (Chennai North District) from No.783 A, 50/2, Thiruvottiyur High Road, Tollgate, New Washermanpet, Chennai- 600 081 (Ward-39).

2. We find that no cause of action has arisen to file the present writ petition in view of the fact that no permission/order has been issued by the competent authority to open the TASMAL Shop No.202. It appears that petitioner has already represented before the
