Learned counsel for the petitioner seeks leave to withdraw the writ petition with liberty to avail appropriate remedy in accordance with law.

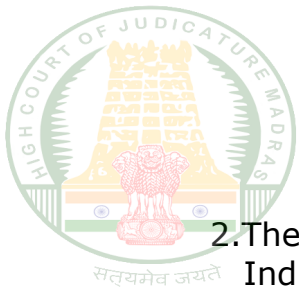
The writ petition is dismissed as withdrawn with the aforesaid liberty. There shall be no order as to costs.
