ORDER

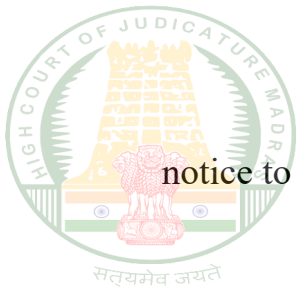
This writ petition has been filed, seeking for a limited relief.
