For the foregoing reasons, this Writ Petition is disposed of, by directing the 2nd respondent to pass final orders on merits and in accordance with law, after giving due consideration to the supporting documents produced by the petitioner and after hearing all the necessary parties, within a period of twelve weeks from the date of receipt of a copy of this order.
