The petition has been filed to direct the respondents to dispose of the petitioner's appeal dated 10.06.2025 on merits.

2. It is the case of the petitioner that the petitioner had executed a settlement deed in respect of his house property in favour of his wife. But, without verifying the above fact, the fourth respondent herein issued an ownership certificate in favour of the petitioner's brother. Therefore, the petitioner filed an appeal before the respondents to cancel the fake ownership certificate issued in favour of his brother, for which, there is no response till date.
