No.4242 / C1/ 2023 dated 09.10.2023 with all consequential and other attendant benefits, salary benefits and monetary benefits from the panel year 2022-2023 in consideration of representation submitted by the petitioner dated 28.02.2024 within a time frame to be fixed by this Honourable Court.

2. The learned counsel for the petitioner submitted that this Court may direct the respondents to consider and pass orders on the petitioners representation within the stipulated time as fixed by this Court.

3. The learned Additional Government Pleader appearing for the



respondents submitted that the representation will be considered and orders will be passed within the stipulated time as fixed by this Court.
