When the matter is taken up for hearing today, the learned counsel for the appellants and the learned counsel for the respondents have appeared before this Court along with their respective parties and they have jointly submitted that both the parties have entered into a joint compromise memo dated 23.02.2026 thereby they have settled their issues amicably during the pendency of the Second Appeal. However, the appellant seeks six month time to comply the terms and conditions of the Memo of compromise.

2.The contents of the above joint compromise memo are read over and explained to both the parties and they would admit the same. The joint compromise memo filed by both the parties is recorded. Registry is directed to keep the joint compromise memo as part and parcel of this Judgment.

3. Accordingly, the Second appeal is disposed of in terms of the joint compromise memo dated 23.02.2026. No costs. Consequently, connected miscellaneous petitions are closed. However, for reporting the compliance in terms of the Joint Memo compromise dated 23.02.2026, as stated in the paragraph 2(i) to (v), post the matter on 24.08.2026. If the terms and



conditions of Compromise Memo dated 23.02.2026, are not complied with within the specified period of six months, the matter shall be reopened again.
