ORDER

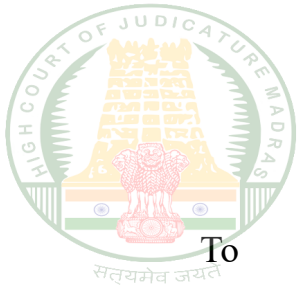
This Contempt Petition has been filed to punish the respondents for non compliance of the order dated 27.11.2025, passed by this Court in W.P.No.46280 of 2025, thereby directing the respondents to consider the case of the petitioner seeking regularization of his service as Forest Watcher from 08.03.1999 notionally for the purpose of getting pension and pass orders on merits and in accordance with law, within a period of twelve weeks.
