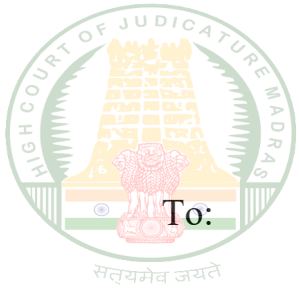
2. The contemnors are present before the Court today. Their presence is dispensed with.
