2. There is no representation on behalf of the petitioner.

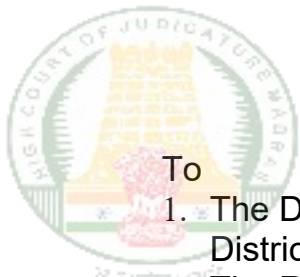
