This case is taken up for settlement before the National Lok Adalat. Both the parties are present. Mr.U.Chithamabaram, learned counsel for the **Appellant** and Mr.D.Baskar, learned counsel for the second **respondent** are present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:

TERMS OF SETTLEMENT

The Tribunal has awarded a sum of Rs.2,87,442/- Lakhs [Rupees Two



Lakhs Eighty Seven Thousand For Hundred and Forty Two only], together with interest at 7.5% per annum, from the date of petition till the date of deposit (excluding the period of dismissal for default, if any). Aggrieved by the award of the Tribunal, the appellant/ claimant preferred the present appeal.

2. After due deliberation and consultation, both the parties have agreed to settle at a sum of Rs.1.00 Lakh (Rupees One Lakh only) over and above the amount awarded by the Tribunal, as full quit compensation, inclusive of the interest and cost.

3. Hence, the second respondent/ insurance company is directed to deposit the enhanced amount of Rs.1.00 Lakh (Rupees. One Lakh only), arrived today, less the amount already deposited if any, within a period of **six weeks** from the date of receipt of a copy of this order, to the credit of M.C.O.P.No1991 of 2021 on the file of the Motor Accident Claims Tribunal (IV Judge, Chennai) and on such deposit, the appellant/ claimant is directed to withdraw the same.

5. The Tribunal is directed to transfer the amount through RTGS/NEFT to the parties concerned on proper identification in accordance with the terms of the award, without insisting on any formal permission petition. The Civil Miscellaneous Appeal is disposed of accordingly.

6. The Civil Miscellaneous Appeal is disposed of accordingly. No costs. Consequently, connected civil miscellaneous petition is closed.
