For the foregoing reasons, this Court directs the third respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 01.12.2025, seeking to upload the sub-division of the property morefully described in the prayer to this writ petition in the website of the Department of Survey and Settlement, Government of Tamilnadu after giving due consideration to the supporting documents produced by the petitioner within a period of twelve weeks from the date of receipt of a copy of this order.
