2. The petitioner had submitted her representation dated 06.10.2025 for the aforesaid purpose. Since the same has not been considered till date, the petitioner has filed this writ petition.

3.Mr.S.Arumugam, learned Government Advocate accepts notice on behalf of respondents 1 to 3. Mr.V.Meganathan, learned Government Advocate (Crl.side) accepts notice on behalf of the fourth respondent. Since no adverse order is being passed against the fifth respondent, notice to the fifth respondent is dispensed with.



4.This Court is not expressing any opinion on the merits of the petitioner's representation.

5.No prejudice will be caused to the third respondent if the said authority is directed to survey and demarcate the boundaries of the petitioner's property, morefully described in the prayer to this writ petition, after hearing the objections if any from the fifth respondent as well as any other party whom the third respondent deems it fit. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the third respondent is directed to issue notice to the fifth respondent and also to any other party, whom the third respondent deems it fit to put on notice.

(b) After receiving objections if any and after considering the same, the third respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.

(c) If the need arises for police assistance and on a request made by the third respondent, the fourth respondent shall



render police assistance for the effective implementation of
this order.
