This petition has been filed for a direction, directing the 3rd respondent to consider and pass orders on the petitioners representation dated 24.11.2025 with regard to issue full and final settlement receipt in discharging the mortgage deed in registered as document No.854/2009 dated 30.07.2009 on the file of the SRO, Barur.

It is the case of the petitioner that the petitioner has obtained a loan from the third respondent Society by depositing mortgage deed on 30.07.2009 on the file of the SRO, Barur, however, no action is taken for registration of receipt cancelling the mortgage deed by the third respondent. In this regard, petitioner has submitted a representation on 24.11.2025 which is pending without consideration. Hence, this writ petition.
