This Civil Revision Petition has been filed seeking a limited relief. The petitioners seek an early disposal of the suit in O.S.No.133 of 2020, pending on the file of the District Munsif Court, Ambattur.

2. Since no adverse order is passed against the respondents 1 and 2 in this civil revision petition, notice to the respondents 1 and 2 is dispensed with by this Court. Mr.V.Balakrishnan, learned Government Advocate, takes notice on behalf of the respondents 3 and 4.

3. Learned counsel for the petitioners submits that the pleadings of the respective parties are complete and the suit is ripe for trial. The petitioners contend that the suit filed by the respondents 1 and 2 is a frivolous suit.
