4. This Court is not expressing any opinion on the merits of the petitioner's representation.

No prejudice will be caused to the second respondent if the said authority is directed to survey and demarcate the boundaries of the petitioner's property, more fully described in the prayer to this writ petition, after hearing the neighbouring land owners as well as any other third party, whom they deem it fit to enquire. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the second respondent is directed to issue notice to the neighbouring land owners, and also to any other third party, whom they deem it fit to enquire.

(b) After receiving objections if any and after considering the same, the second respondent shall conduct survey and demarcate the boundaries of the property more fully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
