### **ORDER**

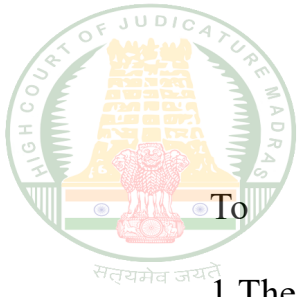
When the matter is taken up for hearing, the learned counsel for the petitioner sought permission of this Court to withdraw the present petition. He has also made an endorsement to that effect.
