When the case was taken up, the learned counsel for the petitioner submitted that this writ petition may be dismissed as withdrawn with a liberty to file a restoration petition of suit in O.S.No.48 of 2016 on the file of the District Munsif Court, Pennagaram which was dismissed as not pressed. He also made an endorsement in the case bundle to that effect.

Recording the submissions of the learned counsel for the petitioner, this writ petition stands dismissed as withdrawn with a liberty to file a restoration petition of suit in O.S.No.48 of 2016 on the file of the District Munsif Court, Pennagaram. No costs. Consequently, connected miscellaneous petition stands closed.
