ORDER

This Writ Petition has been filed seeking for a direction to the respondents to grant patta in favour of the petitioners for the property more fully disclosed in the prayer to this writ petition, based on the petitioners representation dated 06.12.2025, within a time frame to be fixed by this Court.

2. The petitioners claim that they have been in possession and enjoyment of the property from the year 1998 onwards and that they are entitled to the grant of patta. The petitioners had submitted a representation dated 06.12.2025, in this regard to the respondents requesting them to grant patta. Since the same was not considered, the petitioner has filed this writ petition.

3. Mr.R.P.Murugan Raja, learned Government Advocate, accepts notice



on behalf of the respondents.

4. No prejudice would be caused to the respondents, if the petitioners representation seeking for grant of patta is considered on merits and in accordance with law, after hearing the objections of all the necessary parties, within a time frame to be fixed by this Court.

5. This Court is not expressing any opinion on the merits of the petitioners representation.

6. For the foregoing reasons, this Writ Petition is disposed of, by directing the 3rd respondent to pass final orders on merits and in accordance with law, on the petitioners representation, dated 06.12.2025 seeking for grant of patta for the property more fully disclosed in the prayer to this writ petition, after giving due consideration to the supporting documents filed by the petitioner and after hearing the objections of all the necessary parties, within a period of twelve (12) weeks from the date of receipt of a copy of this order. No costs.
