3. Accordingly, this criminal miscellaneous petition is dismissed.

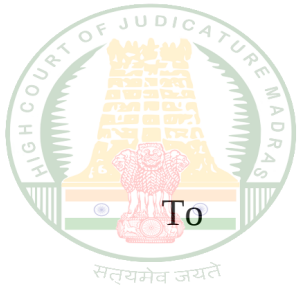
