Nos.711/1 and 712/2 situated at Athikottai Village, Mannargudi taluk, Tiruvarur to their original status and direct the respondents not to alienate, lease, transfer or in any manner encumber the said lands for any purpose other than the original religious purpose or the educational endowment purpose
