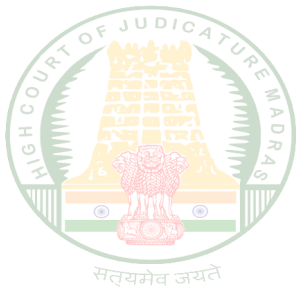

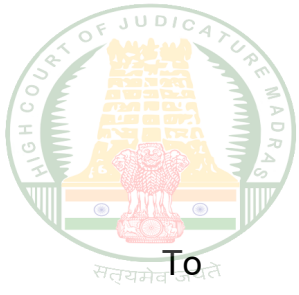
(Judgment of the Court was delivered by S.M.Subramaniam J.)

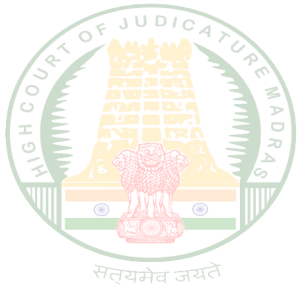
