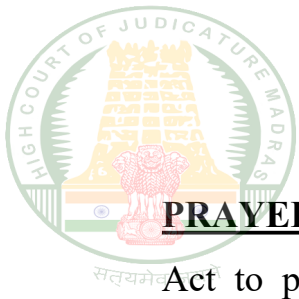

ORDER

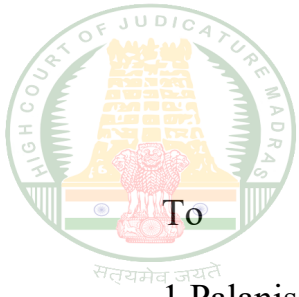
Registry may put up the compliance report filed by the third respondent.
