Learned counsel for the petitioner submitted that the prayer in the Writ Petition has become infructuous.

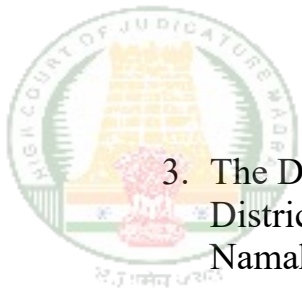
