(a) Before surveying the lands in question, the respondents are directed to issue notice to the neighbouring land owners, and also to any other party, whom they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the respondents shall conduct the survey and demarcate the boundaries of the property morefully disclosed in the affidavit filed in support of this writ petition, on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

(c) There shall be no order as to costs.
