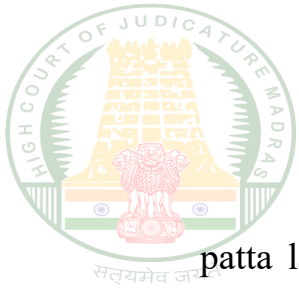
Since the said representation was not considered, this Writ Petition is filed.
