At this Juncture, it is brought to the notice of this Court that, while passing the order dated 04.03.2026 passed in Crl.O.P.No.5465 of 2026, the crime number mentioned at Para No.4 was erroneously mentioned as 'Crime No.60 of 2025' instead of 'Crime No.60 of 2026' due to an inadvertent typographical error. The learned Government Advocate (Crl.Side) also confirms that the correct crime number is 'Crime No.60 of 2026'.

5. Accordingly, the Paragraph No.4 in the order dated 04.03.2026 passed in Crl.O.P.No.5465 of 2026, is corrected by substituting 'Crime No.60 of 2026' in the place of 'Crime No.60 of 2025'.



6. In view of the above, the Registry is directed to carry out the necessary corrections and issue a fresh copy of the order forthwith.
