4. No prejudice will be caused to the respondents if the petitioner's representation, as stated supra, is considered on merits and in accordance with law within a time frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioner's representation.

5. For the foregoing reasons, this Writ Petition is disposed of by directing the first respondent to pass final orders on merits and in accordance with law on the petitioner's representation, dated 07.01.2026 seeking for enhancement of compensation on par with others, who are having the benefit of the order, dated 18.02.2025 passed in W.P.No.4701 of 2025 after giving due consideration to the supporting documents produced by the petitioner and the orders passed by this Court in the Writ Petitions and the Writ Appeal within a period of twelve (12) weeks from
