2. The petitioner seeks for early disposal of the petitioner's appeal dated 11.11.2025 pending on the file of the second respondent.

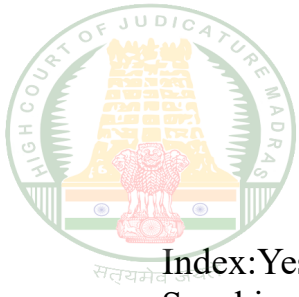
3. Mr. S.Arumugam, learned Government Advocate accepts notice on behalf of the respondents.
