For the foregoing reasons, this Court directs the 2nd respondent to pass final orders, on merits and in accordance with law, on the petitioner's representation, dated 19.02.2026 seeking cancellation of patta now standing in the name of a third party for the property morefully disclosed in the affidavit filed in support of this writ petition, after giving due consideration to the proceedings of the 2nd respondent, dated 07.01.2026 as well as the supporting documents produced by the petitioner and after hearing the objections of all the necessary parties, which includes the third party in whose name the patta presently stands,
