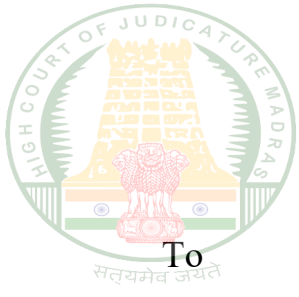
2. Heard the learned counsel for the petitioner.
