PRAYER – This Writ Petition is filed under Article 226 of the Constitution of India, seeking a Writ of Mandamus, directing the respondents to pay petitioner enhanced compensation amount as awarded by the Honble High court Madras Divisional Bench i.e. Rs. 25,952/- per cent 1. Building Koyambedu are hereby requested to pay petitioner the difference amount of Rs. 25,952/- per cent with interest on

For the foregoing reasons, this writ petition is disposed of by directing the first respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 07.01.2026 seeking for enhancement of compensation on par with others, who are having the benefit of the order dated 18.02.2025 passed in W.P.No.4701 of 2025 after giving due consideration to the supporting documents produced by the petitioner and the orders passed by this Court in the writ petitions and the writ appeal within a period of twelve (12) weeks from the date of receipt of a copy of this order. No costs.
