Special Thasildhar Land Acquisition are hereby requested to pay the petitioners the difference amount of Rs.25,952/- (Less) Rs.21,876/- = Rs.4,073/- per cent with interest on solatium is to be given for petitioners' acquired land in Kundrathur village. The petitioners are also entitled to receive the different amount of Rs.4,073/- per cent for petitioners' acquired land in the light of degree and judgment 14.07.2022 passed by Honourable High Court Madras Divisional Bench in A.S.No.386 of 2018 batch cases with all other benefits as per Land Acquisition Act.

ORDER

2. The petitioners had given a representation for the aforesaid purpose to the respondents on 07.01.2026. Since the said representation

was not considered, the petitioners have filed the present writ petition.

4. No prejudice will be caused to the respondents if the petitioners' representation, as stated supra, is considered on merits and in accordance with law within a time frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioners' representation.

5. For the foregoing reasons, this Writ Petition is disposed of by directing the first respondent to pass final orders on merits and in accordance with law on the petitioners' representation dated 07.01.2026 seeking for enhancement of compensation on par with others, who are having the benefit of the order dated 18.02.2025 passed in W.P.No.4701 of 2025 after giving due consideration to the supporting documents produced by the petitioners and the orders passed by this Court in the Writ Petitions

and the Writ Appeal within a period of twelve (12) weeks from the date of receipt of a copy of this order. No costs. W.M.P.No.16498 of 2026 is ordered on payment of separate Court fee.
