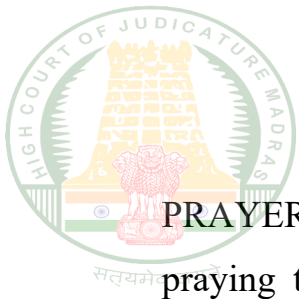

ORDER

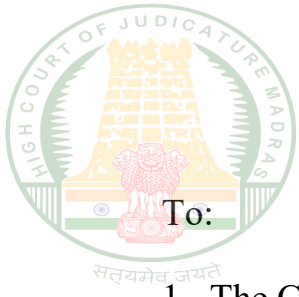
The learned counsel appearing for the petitioner seeks leave of this Court to withdraw the above writ petition and he has made an endorsement to that effect in the case bundle.
