4. The petitioners have filed supporting documents along with this writ petition in respect of the petitioners' representation, dated 16.03.2026. This Court is not expressing any opinion on the merits of the said representation.

5. No prejudice would be caused to the respondents, if the petitioners' representation as stated supra is considered on merits and in accordance with law, after giving due consideration to the supporting documents produced by the petitioners, within a time frame to be fixed by this Court.

6. For the foregoing reasons, this Writ Petition is disposed of by directing the 1st respondent to pass final orders, on merits and in accordance with law, on the petitioners' representation, dated 16.03.2026 seeking confirmation of the alleged pattas issued in favour of the
